**Open Campus Lunch Program**  
**Conditions for Participation**

\*\*Open Lunch is reserved only for **SENIORS** every day and **JUNIORS ON FRIDAYS ONLY**\*\*

Redefining Ready, as part of our District's Strategic Plan, focuses on researched-based criteria that are found in students who are college, career, and life ready. BBCHS seeks to use this readiness status to recognize and incentivize our student body. Open campus lunch is one way the District will celebrate the hard work of our students.

In order for a student to be considered for the Open Campus Lunch program, they must be passing 5 courses and have an attendance rate of 90% or higher. In order to participate, qualified students must have an authorization form completed and signed by a parent. Once signed, qualified students who maintain their Redefining Ready status may leave campus during their normal lunch/study hall period to eat lunch off campus. Eligibility for this privilege will be reviewed weekly. **Students on social probation do not qualify for Open Campus Lunch.**

Students must have in their possession a valid student I.D. card to sign out of the building. Students are to present their I.D. card to the supervisor at the Auditorium Exit when leaving and returning to the building. Students who do not have their I.D. will not be allowed to leave. Altering the I.D. card or presenting an I.D. belonging to another student may cause a student to lose their Open Campus Lunch privilege for the rest of the school year as well as receiving discipline.

Students are expected to leave the school grounds IMMEDIATELY during their lunch/study hall period. Students who are tardy to the auditorium checkout area will be issued a tardy and will not be released for Open Campus lunch. Re-entering the building must occur IMMEDIATELY. Loitering in the building or on the grounds or eating on campus in areas other than those designated is not permitted. During Open Campus Lunch, students may not loiter in areas adjacent to the school grounds. In general, this is interpreted as within visual range of the school. Remember the purpose of Open Campus Lunch is to allow students to leave BBCHS campus to eat elsewhere, NOT to loiter.

Students are expected to abide by all applicable guidelines set forth in the Student Rights and Responsibilities Handbook which includes not disrupting the normal functions of the school. Students must not visit other schools (elementary, junior high, high schools) during Open Campus Lunch. Students may NOT take unauthorized students with them during Open Campus Lunch. Failure to abide by these stipulations will render a student ineligible for the Open Campus Lunch program.

## OPEN CAMPUS LUNCH AUTHORIZATION AGREEMENT AND WAIVER OF LIABILITY

**Terms and Conditions:** "Open Campus Lunch" is defined as a student privilege based on the criteria of Redefining Ready allowing a student to leave the campus of BBCHS during the regularly scheduled lunch/study hall period only. Be aware that during the student's exercise of the open campus privilege, the school's administration may not know the destination, whereabouts, and/or activity of the student; however, the student is still bound by the policies and expectations pertaining to personal conduct as outlined in the student handbook and will be subject to disciplinary action for violations.

Qualifying students who have a signed parental permission form on file in the Student Services Office may participate in Open Campus Lunch privileges. It is the student's responsibility to

- Use the Auditorium doors to exit/enter the building
- Sign in and out whenever leaving the school building
- Return to school on time for the next class period when using this privilege

**Waiver of Liability:** When the student and parent sign the Open Campus Lunch agreement, each agrees to release BBCHS District 307 from any and all liability for a student's actions during his or her exercise of the open campus privilege. Furthermore, the signed agreement also releases BBCHS District 307 from any and all liability for property damage, personal injury, or loss of life while the student is exercising his or her open campus privilege.
